\*\* The schedule is TENTATIVE and subject to change at any time. Please check the website and board at your pool for updates.

- 1) ALL YMCA DUAL MEETS ARE MANDATORY. We will assume you are attending and we must be told if you have a conflict.
- 2) Parents are allowed to select two events for a swimmer to swim. All final decisions are the coaches. Championship meet events are selected by the coaches. Coaches will discuss decisions with swimmers as necessary.
- 3) Please remember that we have timing and other assignments at swim meets. We do rely on parent involvement.
- 4) Please check completed meet entries and if there are any errors speak to a coach as soon as possible.
- 5) We enter trials/finals meets to give our swimmers the opportunity to compete in this format. Our policy is that all swimmers will swim Saturday finals if they make it and Sunday finals are optional (except for championship) BUT STRONGLY ENCOURAGED. If you scratch Saturday finals you will be out of the meet on Sunday, so please do not sign up for a trials/finals meet if there is a conflict with this policy.
- 6) There are minimum requirements (certain number of CT sanction meets) to attend all championship meets. Please make sure you read meet announcement.
- 7) Entry fees will be invoiced directly from the EH YMCA with a due date. Failure to pay in a timely manner may result in swimmers being banned from further meets until fees are paid.
